Introduction

The Specialty Specific Questions have been developed to test trainee's access to, participation in or confidence in the attainment of specific aspects of the specialty training curriculum.

The questions have been included Programme Specific Questions in the annual GMC National Trainee Survey. The details of these questions and the trainee responses (nationally, by Deanery/LETB and by grade can be found within this report.

503 Gastroenterology trainees (117 ST3, 123 ST4, 96 ST5, 88 ST6 and 79 ST7 trainees) an overall increase of 8% compared to 2016, completed the 2017 survey. The numbers of trainees in each Deanery / LETB completing the survey were as follows:

Specialty Specific Questions

Overall, agreement increased in 14 of the 17 Gastroenterology specialty specific questions asked in 2017, however there were significant regional differences. The questions have been ranked highest to lowest percentage of trainees agreeing overall in the summary below. 







Q2. How effective has your training been in equipping you for independent practice in endoscopy? (This question was presented to the following grades: ST7) 2016: n=71, 2017: n=78
